

# **Example 1** Evaluation Criteria Used by the European Commission

Relevance	The appropriateness of project objectives to the initial problems, and to the physical and policy environment within which it operated.
Efficiency	How well inputs/means have been converted into Activities, in terms of quality, quantity and time, and the quality of the results achieved.
Effectiveness	An assessment of the contribution made by results to achievement of the Project Purpose.
Impact	The effect of the project on its wider environment, and its contribution to the wider policy or sector objectives.
Sustainability	An assessment of the likelihood of benefits produced by the project to continue to flow after external funding has ended.



#### **EMWIS Logical Framework Matrix**



The Logical Framework Matrix (or more briefly the Logframe) consists on:

- ☐ The project's hierarchy of objectives (Project Description or Intervention Logic);
- ☐ The key external factors critical to the project's success (Assumptions); and
- ☐ How the project's achievements will be monitored and evaluated (Indicators and Sources of Verification).

Carrying out ASAP satisfaction surveys and corresponding reports (models will
be provided by the following presentations of Faby & Suzan).
Providing annual statistics to show the increase of the NO. of visits.
Signing agreements with the main national water institutions.
Using EMWIS defined common metadata.

#### NFPs are asked to provide:

- Surveys analysis reports
- Copies of newsletters, citations, press releases, etc
- ❖ Web statistics details
- ❖ List of national water institutions & the agreements signed
- ❖ Planning documents related to NWIS or any NWIS funding requests
- ❖ Meetings documents if any (articles published in the media, etc).
