
### WATER COOPERATION SESSION IN MEDITERRNEAN RIVER BASINS

### Introduction

Water is becoming a high priority in all Mediterranean countries, where this scarce resource is essential for the region's development, socio-economic improvement, peace and environmental sustainability.

The entrance into force of the European Water Directive has reinforced the common approach of promoting integrated water management (IWRM) at the basin level. This, in turn, is encouraging the consolidation of River Basin Organisations (RBOs) and the exchange of expertise in the region to ensure an adequate water management.

However, without the cooperation among countries, and specifically between RBOs, and the development of specific projects and initiatives in the region, IWRM could not be achieved.

The Mediterranean Network of Basin Organisations (MENBO) organises, preceding the <u>Euro-Mediterranean Water Directors Conference</u> an open cooperation session, where RBOs can participate and share information on water projects and initiatives obtaining a better approach of the IWRM situation in the region and discuss on-going activities facing region's problems. Mediterranean RBOS, stakeholders, policy-makers, users and NGOs interested in water management are welcome to participate.
