Since 1957, Development has explored alternative perspectives on civil society, development policy, and community-based strategies for livelihoods, gender and social justice. It has a wide and varied international audience of activist researchers, academics, policy makers, members of community based and non-governmental organisations and the general public interested and working on development

Development is calling for papers for the March 2008 issue on 'Water for People'. Kuntala Lahiri-Dutt of the Research School of Pacific and Asian Studies at the ANU and editor of such books as: Water First: Issues and Challenges for Nations and Communities in South Asia (Sage, New Delhi, forthcoming); and Fluid Bonds: Views on Gender and Water (Stree, Kolkata, 2006) will be guest editing this issue.

The focus of this edition is on how human communities shape the ecologies, histories, cultures and the politics of water resource development and planning at global, regional, national and local scales. In recent times, water resources have been at the core of contestations in every aspect of our lives: corporations and states claiming ownership, proclaiming a condition of absolute scarcity, predicting a bleak and gloomy future of conflicts necessitating strict policing to ensure security. Our objective is to stand aside and critique these conceptualisations; to demonstrate that the various community-based, alternative water strategies exist in spite of the current efforts to turn this valuable resource

into a commodity. For this special issue, we lay particular emphasis on seeing water both as the producer and product of human agency, as the basis and outcome of initiatives and alternative strategies of development. Water is much more than just an element of physical nature; it is part of our everyday lives and the cultural landscape, its uses and practices of management are rooted in history, and the control over it represents social and political power. In the contemporary world too, 'empires of water' – resources owned by the states - are inextricably linked with national identities; yet all over the world, communities have and continue to resist statist discourses of water control, and pursuing and practicing a diverse range of alternative modes of water management.

Development would like to invite interdisciplinary explorations from academics and practitioners alike, who can offer new perspectives and insights, explore alternative theoretical models, and offer examples of projects that construct new meanings of water. Development fosters dialogue between academics and practitioners putting forth alternative visions in both the developed and less developed world. The goal of this special issue is to contribute to a new articulation of theory, practice, and ethics that help us better understand and deal with water resources under conditions of globalisation and liberalisation in countries across the world.

The length of contributions to *Development* is usually short (within 3,000 words). We are seeking papers addressing specific themes related to the current debates on water in accessible language, without tables, graphs and figures (unless absolutely necessary). The house style is set out on the website and thematic focus is outlined above.

To be considered for publication you should send a provisional title and a 100 words abstract together with a short biographical statement to <a href="mailto:Kuntala.Lahiri-Dutt@anu.edu.au">Kuntala.Lahiri-Dutt@anu.edu.au</a> by 4 May 2007. If you are selected for publication the full paper should reach Kuntala by 30 October 2007.

Development is also interested in publishing **short summaries** (250 words) of networks and institutes working on water for the Window on the World Section and also **short reviews of books** (5–600 words) on water, **case examples** of community-based initiatives of water management and **stories of water activism** from around the world, and **interviews** with water activists.
